**Documentation**

The following documents need to be provided to DAL Agency prior to vessel arrival in South Africa:

1. The original Bill of Lading indicating Zimbabwe as final place of destination
2. A packing list per container
3. A commercial invoice per container

All documents must be in english, must reflect the name of the actual consignee in Malawi. The packing list must be itemised with a value for each item (customs requirements). No brand names may be used, the description must reflect the actual nature of the cargo. The documents must be clear and legible.

Shipper or Consignee must have a transit risk insurance cover for the cargo

Any storage or detention charges incurred due to late and/or incorrect and/or incomplete documentation will be for account of Merchant.

Empty turn-in in Zimbabwe depending on demand. Please check with DAL Agency before accepting any booking. Transit times depending on customs clearance and any border delays.

Packing declaration - must reflect container number, seal, number of packages, description of goods, weight and measurement
